## Temporary fee structure for 2020

The following fee schedule is applicable for 2020. This year, temporary fees were approved for 2020 to support strategic priorities. The fee increases introduce a differentiation among crop kinds determined by the cost of providing the service and value or potential revenue earnings. Fees relating to variety certification eligibility, penalties for late submissions and other services related to certification have also been temporarily increased. Variety Onboarding	\$150.00	New onboarding variety fee. Applicable to varieties entering CSGA's system outside of the Form 300 or CFIA Variety Registration Process

Appeal Application (Form 200)	\$150.00	Per sequence number
Recertification Fees	\$2,500.00	Per seed source. Additional fees may apply if CSGA is required to do additional consultations.
Varietal Additional Certification Requirements (ACR) Assessment	\$50.00	Per sequence number. Currently only applicable to midge tolerant wheat (MTW) varietal blends

Midge Tolerant Wheat Testing Validation	\$1,200.00	Per MTW blend. Fees are normally charged to the variety distributor.
Land Use Inspection Assessment	\$50.00	Per application (sequence)
Re-inspection Assessment	\$50.00	Per re-inspection
Bulk Application Processing (per field)	\$5.00	Per application (per field) for CSGA to process each field on a bulk application. Online applications are made available at no additional costs.
Breeder Seed Demotion Assessment (Form 45)	\$25.00	Per form
Foreign Canola Support Document Assessment	\$60.00	Per sequence number. Fee for CSGA to process a foreign canola support document assessment; includes crop inspection report, transfer declarations, hybridity test results, and erucic acid results.
Hybrid Canola Support Document Assessment	\$50.00	Per sequence number. Fee for CSGA to process hybrid canola support document and related assessment.
Hybrid Corn Crop Inspection Report Assessment	\$50.00	Per sequence number. Fee for CSGA to process hybrid corn crop support document and related assessment.
Carry Over Seed Listing Fee (per variety/class)	\$50.00	Per crop certificate per year. Fee for CSGA to process request for carry over seed listing per variety or class.

ASCIS Annual Software Licensing Fee	\$500.00	Annual, per license. Some ASCIS's may have more than one license.
ASCIS Initial Software Licensing Fee	\$2,000.00	Per license for the onboarding of new ASCIS's (initial licensing of software)
ASCIS System Access Fee (Non Hybrids)	\$0.12	Per acre
ASCIS System Access Fee (Hybrid)	\$0.22	Per acre

No Valid Email	\$10.00	Per application (sequence) applied when no email has been provided for the account receiving certification services.
Inspection Cancelled	\$50.00	Per cancelled application (sequence)
